WHEREAS, Mr. Mark Henry is owner of Catering Unlimited; and

WHEREAS, At the February 16th, 2010 meeting of the Springdale Advertising & Promotion Commission, the commissioners unanimously voted to recommend the appointment of Mr. Mark Henry, to complete the unexpired term of Seat #4, followed by an appointment to a full four (4) year term.


